43 teachers responded to the feedback form. The questionnaire was prepared to test on three areas: Administration, Infrastructure and working environment. The administrative mechanism was found to be excellent according to 89% of the teachers. Around 80% teachers felt that administrative support in various activities of the college is excellent. 90% teachers felt that the institutional values and goals are abided by the administration. 94% felt that the administration always provide excellent leadership. 90% teachers opined that administration acknowledges the opinions of all the teachers in the decision making. 85% teachers think that the classrooms of the college are well equipped with provision of ICT. 90% teachers think that the sanitation facility is very good in the college. 80% teachers rated the canteen to be satisfactory. 85% teachers felt that the autonomy of the teachers is always seen in promoting teaching excellence to enhance learning. The satisfaction towards the academic environment is seen to be impressive. 95% teachers felt that the administration practices e-governance. 95% teachers felt that the administration takes effective steps in promoting research for teachers. 98% teachers felt that the administration gives permission to the teachers for participating in FDP, Orientation Programme and Refresher Courses.
