N.B

- (2) **Mere publication of names in the merit list does not guarantee admission into the institution. Admission will be based on verification of records and eligibility.**
- (3) Admission in the reserved category will not be considered without proper Caste Certificate. Caste Certificate of the parents and caste certificate application acknowledgements will not be considered as a proof of reserved category under any circumstances.
- (4) Only the certificate from the Circle Officer/ Court Affidavit will be considered as income proof. The authority reserves the right to certify the income on production of satisfactory income proof.
- (5) The absentee from the previous merit list will not be considered in the subsequent merit list.
- (6) If any submitted document is found to be fake/tempered/forged or not in order at any point of time, the candidate will be liable for legal action and cancellation of admission.
- (7) The applicants who have taken admission on the basis of previous merit list, the if the same applicants' names are published in the subsequent merit list due to the submission of additional application forms, then the previous admission will only be considered.
